22/01075/FUL Worcester City CA Erection of sculpture, seating area and associated landscaping works. Diglis Weir Adjacent to Bromwich Parade Public Right of Way 938 (A) Near Weir Lane Worcester Diglis WR2 4ZP

22/01077/PRA Worcester City CA Prior approval for a change of use of upper floor to create 2 x 2 bed dwellings (use class C3) 68 Broad Street WORCESTER WR1 3LY

22/01082/HP Worcester City CONLB New storage building and rear boundary wall alterations. Repointing and undertaking repairs to brickwork to some of the external wall of the main house, Replacement of existing plastic corrugated sheeting rooflight with a conservation roof light/ window. Internal alterations to the Corn Exchange to include partial demolition to first floor for new escape stair, demolition, and reconfiguration of existing walls to basement and ground floor levels, demolition to form new opening in party wall at first floor to connect the Scala performance arts centre and Corn Exchange and existing services upgraded throughout.
